INTRODUCTION

This particular charging instrument is within the jurisdiction of the WAR CRIMES TRIBUNAL due to the nature of the crimes herein.



NATURE OF THE CRIMES:

MARK ZUCKERBERG, an inhabitant, (Law of Nations- section 213), (hereinafter: "ACCUSED") ACCUSED and CEO of an online social media platform, "FACEBOOK", arbitrarily declared six online personalities as "Dangerous Individuals" on or about May 2nd, 2019 thereby declaring the six individuals "terrorists", an international crime punishable by execution. The six individuals (hereinafter; "VICTIMS") are listed as follows:

- 1: Alex Jones- inhabitant
- 2: Paul Joseph Watson-inhabitant of England
- 3: Milo Yiannopoulos-inhabitant
- 4: Louis Farrakhan-inhabitant of the Nation of Islam
- 5: Laura Loomer- inhabitant
- 6: Paul Nehlen-inhabitant



At the time of the arbitrary declaration, the following conditions were met to declare the announcement and classification as “arbitrary” and not based in fact under any form of free speech exercised by the ACCUSED:

- 1: No charges existed against any of the inhabitants in the nature of terrorist activity.
- 2: No trial for terrorist activity against the VICTIMS existed at the time of the arbitrary declaration was made and published by the ACCUSED.
- 3: None of the VICTIMS declared war against the ACCUSED.
- 4: None of the VICTIMS were involved in any terrorist activity, threats or otherwise posed a threat to the country nor the security of the country at the time of the arbitrary declaration was made and published by the ACCUSED.

The arbitrary declaration published by the ACCUSED against the six victims re-classified the VICTIMS persons as dangerous individuals which opens up the possibility of each of those VICTIMS to possible arbitrary execution on the street by anyone that may see them or identify those VICTIMS in stores, places of work, spending time with their families, or any other non-work related activities.

The arbitrary declaration made by the ACCUSED against the VICTIMS was leaked to the media wherein the corporate and privately owned media began to chant the arbitrary declaration made by the ACCUSED all over the world thereby further endangering the lives of the VICTIMS.

CHARGES AGAINST THE ACCUSED:



- 1: Six counts of attempted murder.
- 2: Six counts of inciting international violence against civilians-classified as War Crimes.
- 3: Six counts of attacking civilians while protected by the U.S. Military- classified as War Crimes.
