Starling, Jr.**, 5) **Rapides Parish Sheriffs Department**, 6) **Robin L. Hooter** respectively named in the above referenced case, the office of the Treasury for The United States of America hereby declares the assessed value of this case in the amount of twenty-two million five hundred thousand (+22,500,000.00) each for a total amount of one hundred thirty five million (+135,000,000.00) legal tender whether in Continental Dollars or equivalent to; and

**FURTHER BE IT RESOLVED**, that in regards to damages by 1) **John W. Russell IV**, 2) **R. Kyle Ardoin**, 3) **Tracy Liotta**, 4) **Matt Dautat**, respectively named in the above-referenced case, the office of the Treasury for The United States of America hereby declares the assessed vale of this case in the amount of two million five hundred thousand (+2,500,000.00) each for a total amount of ten million (+10,000,000.00) legal tender whether in Continental Dollars or equivalent to; and

**FURTHER BE IT RESOLVED**, that in regards to the damages by the respondent(s), the office of the Treasury for The United States of America hereby declares the **TOTAL** assessed value of this case in the amount of one hundred forty five million (+145,000,000.00) payable in Legal Tender, land or cured trust property under the classification of a fine allocated towards damages caused by international violations of The Universal Declaration of Human Rights; and
